# **ISSUE: The Tomorrow Plan Schedule**

#### **BACKGROUND:**

With the development of The Tomorrow Plan winding down, the planning team is looking to keep the momentum of the plan moving forward. As a beginning implementation mechanism, the team will be looking for approval from the Steering Committee, the MPO, and the communities and counties. The team proposes the following:

- August: Review of final draft plan
- September: Votes by Steering Committee and MPO committees
- October December: Votes by communities and counties

When the plan is taken to the communities and counties, the councils and boards will be asked to approve general resolutions of support. While the language of the resolution still is under development, it will reflect the idea that, as communities and counties update their plans and codes, they will look to The Tomorrow Plan as a guide and will work to implement its goals and strategies as appropriate.
